MARK Alert – Adjusting Price Target to Reflect 10-for-1 Stock Split; No Impact on Balance Sheet

- •MARK's 10-for-1 stock split goes into effect today. Masraf Al Rayan's (MARK) 10-for-1 stock split has resulted in 7,500,000,000 shares vs. 750,000,000 previously.
- •Price will change. Following the stock split, the price has changed to QR3.62 vs. previous close of QR36.20.
- •Our Price Target will be adjusted following the stock split. Our Price Target on MARK will be adjusted to QR3.40 from QR34.00.
- •No Impact on capital. The bank's capital will remain the same at QR12.3bn as of 1Q2019.
- •No impact on market cap. Market cap remains the same at QR27.2bn/\$7.5bn.
- •No Impact on ownership structure. Ownership structure will remain unchanged.
- •Recommendation & valuation: MARK trades at a P/E and P/B of 12.4x and 2.0x based on our 2019 estimates, respectively. We maintain our Market Perform rating.
