



Commercial Banks Credit Facilities

As at January 2023






- Loans declined by 0.9% during January 2023 to QR1,244.9bn
- Loans decline in January 2023 was mainly due to a drop by 3.1% in the public sector
- Loans have gone up by 3.3% in 2022, compared to a growth of 7.8% in 2021. Loans grew by an average 6.7% over the past five years (2018-2022)



Commercial Banks Deposits

As at January 2023






- Deposits dropped by 3.9% during January 2023 to QR960.2bn
- Deposits drop in January 2023 was mainly due to a 9.4% fall in public sector deposits
- Deposits have increased by 2.6% in 2022, compared to a growth of 7.6% in 2021. Deposits grew by an average 4.0% over the past five years (2018-2022)

(%)




- Loans to Deposits ratio shot up during the month to 129.6% as at January 2023
- Loans declined by 0.9% in January 2023 to QR1,244.9bn, while Deposits dropped by 3.9% in January 2023 to QR960.2bn

- The Net Interbank Position was at a negative QR276bn as at January 2023
- Due from Banks totaled QR157.3bn as at January 2023
- Due to Banks totaled QR433.5bn as at January 2023
- Due to Banks Abroad reached a high of QR403.4bn in December 2022
