


SPINEL RC FUND ISIN KYG835251086 Fund Fact Sheet – DECEMBER 2023

Investment Objective

The investment objective of the Fund is to generate a constant stream of cash flows by investing into Reverse Convertibles (RCs), Structured Notes, derivatives and cash or cash equivalent instruments.

Investment Strategy

The Fund will invest primarily in Auto-Callable Reverse Convertible and other Structured Notes related to equity, currency, commodities and indexes, related derivatives and cash or cash equivalent instruments for liquidity purposes. The investment strategy will seek to harvest instruments volatility and convert it into cash flows whilst controlling the idiosyncratic risk of a single name investment exposure and the related business sector

Allocation

- -During the month of December 23, no new additional subscription were received into the RCF. However, the fund experienced an increase in the unit price compared to last month the NAV in November was 9.592, whilst the December NAV was 9.879. It should be noted that a new subscription was received at last day of December which will settle in January.
- -A new RC note will be added to the fund due to the new money received.

General Considerations on the stock market

- -The average value of the US equity reference index for increased by 4.5% in December. Additionally, there has been a slight decrease in volatility from November to December, with current volatility standing at 12.5 compared to 12.9 in December. These events were positive for the performance of our fund.
- -Regarding funding rates, there was a 33-basis points decrease (from 5.1 to 4.8) for the average 12-month residual life of the US Treasury. However, this decrease had no noticeable impact on the pricing of the RC fund. During their last meeting in 2023, the Federal Reserve decided not to raise interest rates, extending the period since the last hike to over four months. This decision aligns with the interests of the RC fund.
