

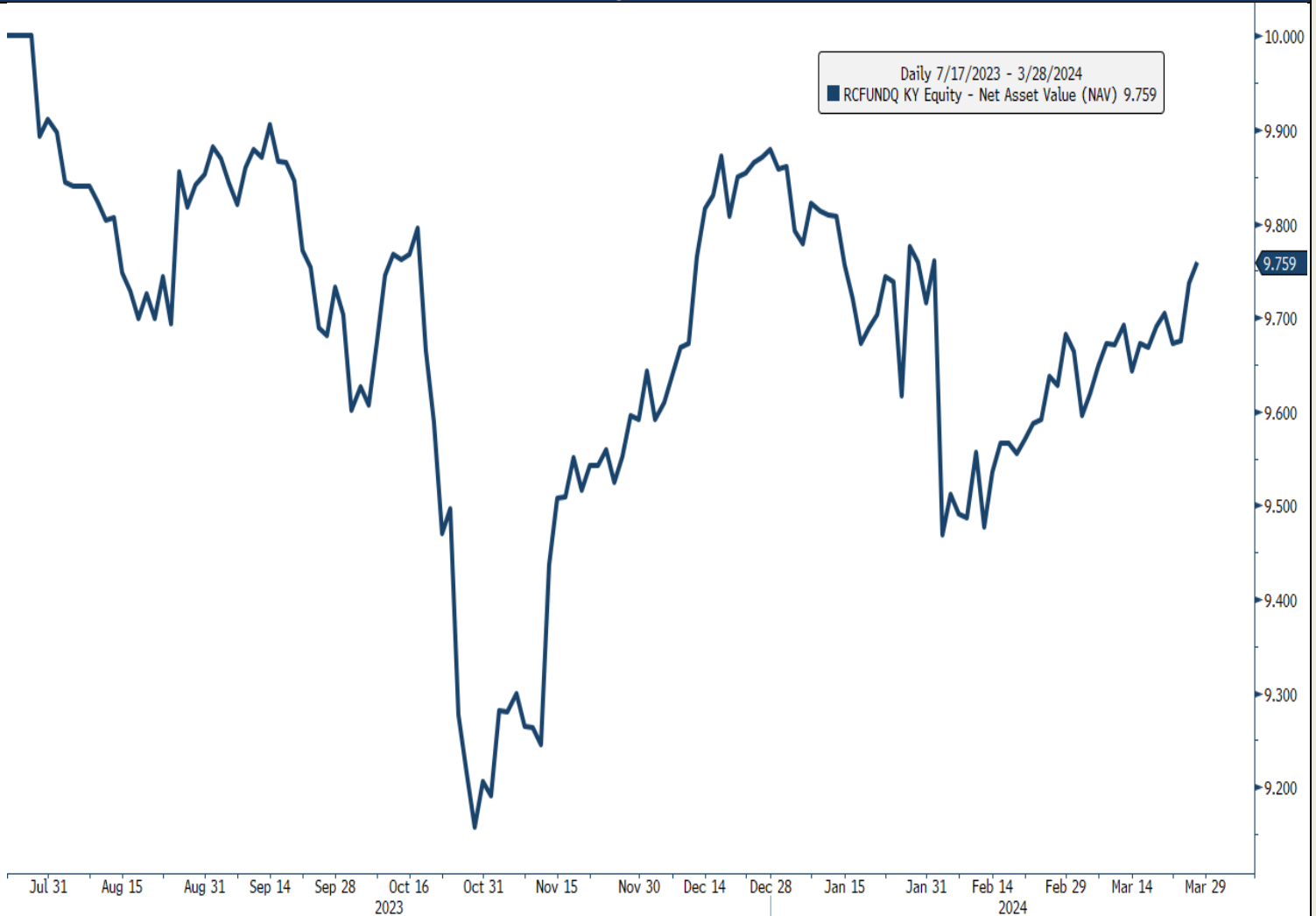
Investment Objective

The objective of the Fund is to generate a constant stream of cash flows by investing into Reverse Convertibles (RCs), Structured Notes, derivatives and cash or cash equivalent instruments.

Investment Strategy

The Fund will invest primarily in Auto-Callable Reverse Convertible and other Structured Notes related to equity, currency, commodities and indexes, derivatives and cash or cash equivalent instruments [for liquidity purposes]. The investment process is designed to harvest markets' volatility and convert it into cash flows whilst controlling the idiosyncratic risk of any single name investment exposure and the related business sector via concentration limits.

Major Fund Allocation changes

The nominal investment in the QNB RC Fund currently stands at approximately \$31.5 million, boasting an average coupon rate of 13%. During the month of March we successfully deployed the \$5 million raised and introduced two new single lines, thereby increasing the total count of single RCs to 19. Additionally, the fund is scheduled to pay management fees to QNB for the first quarter of 2024 in the first week of April.

At the time of writing this summary, 2 single RCs could be called for a total amount of 12.2% of total AUM of the fund.

General Considerations on the stock market

- The performance of the US equity reference index was up 3.7% in March.
- There has been a slight decrease in volatility from February to March currently standing at 13.1% compared to 13.4% in February. This is beneficial for the fund.
- There was no material increase for the average 12-month residual life of the US Treasury yield [from 4.9 to 5.0]. with a negligible impact on the secondary market pricing of the single RCs fund.
